U.S. GOVERNMENT REGULATED

Pioneer Commodities is licensed and registered with the CFTC, an independent federal regulatory agency. We are a member of the NFA, the industry controlled self-regulatory agency. All of our brokers are fully licensed and federally regulated by the U.S. Government. The clearing member firms are registered with the CFTC.

FUNDING YOUR ACCOUNT

Pioneer Commodities has selected a well-respected exchange clearing firm to hold your account and clear all commodity transactions. That firm uses only FDIC insured banking institutions to clear and carry our clients' funds. All checks and monies for your account must be made out to the clearing member firm and not to Pioneer Commodities. Clearing member firms are subjected to strict financial requirements and U.S. Government regulations.

MOVEMENT OF FUNDS

The premiums you pay for your options to the clearing member are transferred to the appropriate commodity exchange trading floor (Chicago Board of Trade, Chicago Mercantile Exchange, New York Mercantile Exchange, New York Coffee, Sugar & Cocoa and others), to pay for your option purchase. It is the responsibility of every exchange clearing house to match all purchases and sales and to assure the sale transfer of funds from option purchaser to option seller.
